Trevethan believes the ramp leading to the rear entrance is dangerous, in need of repair, should be removed and become "employee's entrance only" due to safety/liability purposes/concerns. Miller states CDBG monies could possibly be used. Scheib-Snider states the lift utilized CDBG monies, so monies would be unavailable for this use. Scheib-Snider requests that two (2) RFP's be obtained for work to be performed. Kemp is concerned if lift was not working there would be no access to building. Trevethan will look into options/requirements.
