WHEREAS, the Rose Township Board of Trustees has duly advertised a public hearing on November 1, 2012 for the purpose of receiving comments regarding the proposed reprogramming of 2011 Program Year Community Development Block Grant funds in the amount of \$8,293, and;

A. Resolution 2013-XX to Continue Moratorium Regarding Michigan Medical Marijuana

Supervisor Gambka states the Township has a moratorium on this matter, awaiting guidance from the State of Michigan.

PROPOSED RESOLUTION #2013-37 TO CONTINUE MORATORIUM REGARDING MICHIGAN MEDICAL MARIJUANA ACT MCL 333.26421, ET SEQ.

WHEREAS, the State of Michigan, by voter referendum in November 2008 approved the use of Medial Marijuana, which resulted in the enactment of the Michigan Medical Marijuana Act (MMMA) MCL 333.26421 to 333.26430 effective December 4, 2008;

WHEREAS, the MMMA and State regulations have not addressed the appropriate land uses associated with these activities, including the sale or dispensing of Medical Marijuana;

WHEREAS, the Rose Township Board finds that it is desirable to forbid the establishment of facilities, which sell or dispense Medical Marijuana, in order to protect the public health, safety and welfare until such time as further direction is provided by State Legislation or until the Township adopts regulations pertaining to sales and dispensing.

WHEREAS, the Rose Township Board finds that a moratorium from the date of the adoption of this resolution until April 9, 2014 is appropriate to prevent the establishment of any facilities which sell or dispense Medical Marijuana to protect the public health, safety and welfare until such time as the Rose Township Planning Commission is able to make a decision pertaining to the adoption of regulations, if necessary, regarding the sale and dispensing of Medical Marijuana.

NOW, THEREFORE, BE IT FURTHER RESOLVED, that the Rose Township Board hereby adopts a Moratorium on the establishment of any facilities which cultivate, process or store Medical Marijuana for sale or dispensing within the Township for a period of 6 months from the passage of this Resolution. Said Moratorium prohibits the issuance of permits and licenses pertaining to facilities which cultivate, process or store Medical Marijuana for sale or dispensing including, but not limited to, Building Permits, Sign Permits, Certificates of Zoning Compliance and Certificates of Occupancy. During the 6-month period, this matter will be referred to the Rose Township Planning Commission to consult with its Planner and Legal Counsel to further research the foregoing issues and draft the appropriate zoning regulations, if necessary, in conformity with the MMMA and any further pending bills which may be forthcoming from the Michigan Legislature.

Moved by Miller, seconded by Kemp, motion carried to approve the Resolution continuing the moratorium regarding the Michigan medical marijuana matter.

Trevethan states property transfer affidavit penalties were previously discussed and presents a pamphlet describing same. Fifty-three fines total: ten (10) fines cancelled due to Rose Township not Page 3

filing paper work with Oakland County, five (5) waived by Rose Township Board of Trustees, twenty (20) fines paid (by mortgage companies), and eighteen (18) remain unpaid. Realized \$2,500.00 out of \$8,000.00. Trevethan does not see a benefit, no real revenue source, consider eliminating fees. Kemp supports eliminating penalties. Supervisor Gambka does not believe imposing penalties is a service to the Township.

Moved by Trevethan, seconded by Kemp, motion carried to waive the property transfer affidavit penalties effective going forward as of this date.

Scheib-Snider asks if past penalties will be waived. Trevethan explains only going forward. Miller asks if residents can ask for a refund if they previously paid penalties. Trevethan responds no, this decision is going forward from this date.

Kemp asks if the Board agrees the ramp should stay. Trevethan states the ramp only serves one (1) floor and the elevator does not work properly, needs repair. Supervisor Gambka states even if working properly, elevator is small.

<u>Tom Willwerth, Resident</u> states residents are confused by the ramp and tree removal matter. Resident was at the old Township Hall and feels the Township should be ashamed by the condition of the ramp/ front of building. There is an odor.

<u>Tim Claus, Resident</u> states he supports keeping/repairing the ramp. Resident states there should also be a camera located in the Board meeting room.
