Scheib-Snider has received complaints about signage left on the telephone poles.

<u>Unidentified Resident</u> states the \$25,000.00 grant from Enbridge is good, but Enbridge is still causing residents problems (blocking ingress/egress, noise, etc.). Supervisor Gambka states Enbridge is offering those residents affected hotel accommodations and providing financial compensation for disruption(s).

<u>Darlyne Stanczk Resident</u> states she was unaware there was a planning commission meeting last week due to the website being outdated. Minutes are also not updated on the website. Supervisor Gambka will speak to the Clerk regarding the status of the website.

<u>Glen Noble</u>, <u>Resident</u> states the Board of Review has good market values and good comparisons on properties.

<u>Unidentified Resident</u> is concerned about Enbridge giving us grant, why? Supervisor Gambka states Enbridge has established an environmental stewardship program providing grants to townships. Resident asks about the Township Annual Meeting. Supervisor Gambka states Rose Township is the only Township in Oakland County still holding an annual meeting and the Board will decide if the annual meeting is necessary going forward.

<u>Unidentified Resident</u> does not disagree with \$25,000.00 Enbridge grant and believes it is good for the Township.

<u>Tom Willwerth, Resident</u> asks for an update on the military markers in lieu of flags request, would like budget for this approved for May. Will provide Board with samples at next meeting or before.

<u>Darlyne Stanczyk, Resident</u> asks as to the outcome of the discussion regarding Mr. Claus' Zoning Board of Appeals appointment. Supervisor Gambka states the Township Attorney approved Mr. Claus' appointment on the Zoning Board of Appeals.

<u>Diane Howell, Resident</u> states HAYA is celebrating its fifty (50) year anniversary and there will be a homemade turkey dinner. Asks residents to phone in reservation(s).

<u>Unidentified Resident</u> asks why the Township cannot have just one (1) trash hauling company.

<u>Unidentified Resident</u> speaks as to trash haulers in Rose Township. Supervisor Gambka states recycling will be looked into.

<u>Unidentified Resident</u> states if Holly Township wins a battle against him, mortgage companies can sub-divide properties, etc.

<u>Unidentified Resident</u> states the Village of Holly has weekly cart recycling and private trash hauling. Prevent multiple trucks from travelling on the roads.

<u>Unidentified Resident</u> asks if Enbridge is being charged a personal property tax on the sites they are using.

<u>Unidentified Resident</u> states Enbridge came to resident's house and destroyed his property, offering him a fraction of what the property is worth.
