#### PRESENTATIONS:

<u>Joe Graves, State Representative</u> – Presents Certificates of Appreciation for Boy Scout project to: Matthew Stevens, Dylan Morgan, Jake Osborne, Alec Minard, Jacob Barlow, and Kyle Carol. Special mention to Ryan Osborne and his participation/volunteer work with headstones at the cemetery. Tom Willwerth states Ryan Osborne is dedicated and did a great job, 139 headstones/plus 16 stones. Mr. Willwerth thanks everyone for their assistance.

Rana Emmons, CPA, PSLZ, LLP, Rose Township Audit/FY 2013. Ms. Emmons states this is PSLZ's first year serving as auditor with Rose Township. Property taxes decreased by one (1%) percent, last year before a four (4%) decrease. Shared Revenue increased by one (1%) percent, seeing trend of increases. General Fund balance - \$153,000.00. General Fund Expenditures - \$108,000.00 under budget. This is the result of the Board keeping an eye on expenditures and not spending. Total General Fund decreased slightly by \$17,000.00. Ms. Emmons states Rose Township received an unmodified audit opinion which is the highest audit opinion possible, a good audit. Thanks everyone at the township hall and Clerk and Treasurer for being so accommodating. Audit was condensed down to less pages, easier to read.

<u>Leon Sharpe, HSB, School Board Presentation</u>, states there has been declining enrollment, buildings closed in order to save money. Currently stabilized and growing enrollment, re-opening KRC on May 29, 2014. Sherman Middle School is ready to open. At this time the budget is stable.

#### PUBLIC COMMENT ON AGENDA ITEMS ONLY (limit comments to 3 minutes each item):

<u>Glen Noble, Resident,</u> mitigation plan/solid waste plan. Resident wants to make sure Township is protected. Resident supports reinstating the Annual Meeting.

<u>Greg Parker, Resident</u> states he was involved in Pontiac's solid waste plan, created new jobs and is a win-win situation.

<u>Tom Willwerth, Resident</u> states changes have been made regarding mowing contract and appreciates the changes. Contract will be upheld now. Resident would like to see more residents at the meetings. We elected five Board members and residents should have confidence in them to Resident's suggests a Township-wide survey regarding the Annual Meeting debate.

<u>Chester Koop, Resident</u>, is surprised/disappointed that this is the first time the Annual Meeting is on the Agenda. Resident states the Annual Meeting allows residents to annually set the board members wages and he supports reinstating the Annual Meeting. Resident would like to see a motion/vote on the subject so Board is on record. Suggests reinstating because there are other ways to have it reinstated.

<u>Tim Claus, Resident</u>, asks Board not to accept a mowing contract based only on lowest bid, much more to be considered. Sticks and debris not picked up last year. Resident is also asking the Board to award his company the contract as he is a local contractor and provides exceptional service.

<u>Marilee Karstens, Resident,</u> supports reinstating the Annual Meeting, believes the Annual Meeting could be improved upon and more inviting.

A. Discussion of Rose Township Buy-Back of Cemetery Plots When Requested by Owner (Tabled)

#### ADOPTION OF THE OAKLAND COUNTY HAZARD MITIGATION PLAN

WHEREAS, the mission of Rose Township includes the charge to protect the health, safety, and general welfare of the people of Rose Township; and

WHEREAS, Rose Township, Michigan is subject to flooding, tornadoes, winter storms, and other natural, technological, and human hazards; and

WHEREAS, and the Oakland County Homeland Security Division and the Oakland County Local Emergency Planning Committee, comprised of representatives from the County, municipalities, and stakeholder organizations, have prepared a recommended Hazard Mitigation Plan that reviews the options to protect people and reduce damage from these hazards; and

WHEREAS, Rose Township has participated in the planning process for development of this Plan, providing information specific to local hazard priorities, encouraging public participation, identifying desired hazard mitigation strategies, and reviewing the draft Plan; and

WHEREAS, the Oakland County Homeland Security Division (HSD), with the Oakland County Local Emergency Planning Committee (LEPC), has developed the OAKLAND COUNTY HAZARD MITIGATION PLAN (the "Plan") as an official document of the County and establishing a County Hazard Mitigation Coordinating Committee, pursuant to the Disaster Mitigation Act of 2000 (PL-106-390) and associated regulations (44 CFR 210.6); and

WHEREAS, the Plan has been widely circulated for review by the County's residents, municipal officials, and state, federal, and local review agencies and has been revised to reflect their concerns; and

NOW THEREFORE BE IT RESOLVED by the Rose Township Board of Trustees that:

- 1. The Oakland County Hazard Mitigation Plan (or section(s) of the Plan specific to the affected community) is/are hereby adopted as an official plan of Rose Township.
- 2. The Fire Chief is charged with supervising the implementation of the Plan's recommendations, as they pertain to Rose Township and within the funding limitations as provided by the Rose Township Board of Trustees or other sources.

# Rose Township 2014-11 Solid Waste Management Plan Amendment Resolution

WHEREAS, Oakland County ("County") has a Solid Waste Management Plan ("Plan") that was prepared in accordance with Public Act 451, as amended, 1994, Part 115; Solid Waste

Management; and

WHEREAS, the law requires that the Plan identify all solid waste landfills, Type A Transfer Stations, and Waste Processing Facilities within the County and that the Plan must be amended if the County desires to include new facilities or sites; and

WHEREAS, the Oakland County Executive received a request to amend the County Solid Waste Management Plan for the inclusion of a proposed Type A Transfer Station and a Waste Processing Facility to be located on the same piece of property in Pontiac at 900 Baldwin Avenue from Pontiac Baldwin, LLC and Rizzo Properties LLC ("Requested Amendment"); and

WHEREAS, The Oakland County Solid Waste Planning Committee ("SWPC"), along with the staff of the Oakland County Economic Development & Community Affairs Department, which is the Designed Planning Agency ("DPA") for Oakland County have met and discussed this requested amendment to the Plan; and

WHEREAS, the Oakland County Solid Waste Planning Committee authorized by resolution that the requested amendment be released for the required 90-day public comment period which was held from December 14, 2013-March 17, 2014 and was widely publicized to all Oakland County municipalities, adjacent counties, the Board of Commissioners, the MI Department of Environmental Quality, SEMCOG and other interested parties; and WHEREAS, notice of the public comment period and date of a public hearing was published in The Oakland Press on December 13, 2013 and all corresponding documents were available for public review in the Oakland County One Stop Shop, as well as on the Oakland County website; and

WHEREAS, the applicants ,Baldwin Pontiac, LLC and Rizzo Properties LLC have entered into a host community agreement with the City of Pontiac to provide the City of Pontiac additional benefits; and

WHEREAS, a public hearing was held on February 26, 2014 at the Oakland County Executive Office Building; and

WHEREAS, the SWPC met after the end of the 90-day public comment period and reviewed the transcript of the public hearing and considered all written and verbal public comments received during the meetings and public comment period. The SWPC approved the requested amendment and recommended that it be forwarded to the Oakland County Board of Commissioners for consideration; and

WHEREAS the Oakland County Board of Commissioners approved the requested amendment at its April 17, 2014 meeting; and

WHEREAS, per Public Act 451, Part 115, Solid Waste Management, Section 11536, it is a requirement that a solid waste plan amendment must receive support via resolution by no less than 67% of the local units of government within the respective county before being sent to the Michigan Department of Environmental Quality for approval;

# L. Discussion of Annual Meeting

Scheib-Snider states certain people are upset that there will not be any Annual Meeting, asks Board if it has reconsidered. Kemp states he understood the meetings became ugly. Supervisor Gambka states there are many misconceptions surrounding the Annual Meeting. The Annual Meeting was in fact, the budget meeting, salaries are included in the budget, and the meetings became ugly. Originally, when the Township was smaller, people would get together and approve salaries. Many personality conflicts and used the annual meeting forum to get back at them. This is incorrect, the salaries are already set at this meeting and they cannot be cut, can only be increased. Supervisor continues, the Township Board is elected for a four (4) year term. Boards are entrusted to run the Township; to that end it sets salaries and is held accountable at the end of its term. Look at history of the township and the Salary Survey. The Salary surveys show Rose Township's Board is not overpaid when compared to the other townships. Miller states the Board, in fact, under-compensated. Miller reiterates that the budget is discussed at Annual Meetings. Attorney Mulvihill states Rose Township is not used in Oakland County anymore and Rose Township was one of the last

communities to continue to hold an Annual Meeting, other townships have done away with Annual Meeting. The Board has the budget hearing which includes the salary and you vote every four years. The Electorate can petition and hold an election if the township residents feel that strong. The powers of the Electorate at the Annual Meeting are very restricted. The Electorate and only appoint two more trustees at an annual meeting after petition and election. Supervisor Gambka states he is holding a Special Budget Meeting for the public on June 11, 2014 and the budget vote will occur June 18, 2014. These meetings are open to the public for their opinions/suggestions. Supervisor Gambka reiterates there is a lot of misinformation regarding the Annual Meetings. Supervisor Gambka states 30-40 people show up, this is not representative of "whole" Township; just a quaint tradition. The Board is elected as a democracy to run the Township. At an Annual Meeting Board members could conceivably have all their friends show up and vote to give a Board member a raise; we don't want that to happen. Supervisor Gambka states this decision is not personal, just bringing Rose Township into the 21st century. The Annual Meetings were turning into a negative forum, with only a minute percentage of Township representing. Supervisor Gambka would like to focus on the budget right now. Residents are taking the Annual Meeting personally and it is just simply removing an antiquated process. Miller would like to first see how the budget meeting goes on June 11, 2014, this will be a longer meeting where more input can be received, and essentially this is the same components of an Annual Meeting.
