Tom Willwerth, Resident states the Board continues to ignore his concerns, etc. regarding cemetery

issues and provides a hand-out regarding burial locations/lots errors. There are burials in the wrong lots, paperwork must be changed/amended. Resident states Supervisor Gambka needs to address these matters, work more hours if necessary, these unresolved issues are his responsibility. Resident states he will contact the media if the cemetery issues are not addressed/handled, asks the Supervisor to resign.

<u>Linda Dagenhardt, Resident</u> flags. Thanks the Board for placing the flags out. Only problem being, the Board told the newspaper the flags were out on Memorial Day, when in fact they were not. Resident states Ms. Lumley is divorced and asks the Board why her husband is still on the insurance policy. Miller responds that the divorce was final in September and the divorce decree has been sent to insurance company, Lumley needs to call insurance company herself in order to remove husband. Scheib-Snider states the Supervisor could facilitate this matter, the Township should not be paying for and insuring an ex-spouse. Resident states Clerk should be eligible for compensation in lieu of not using insurance.
