<u>Dan Johnson, Resident</u> states since the late 1970's-80's Tipsico Lake has experienced a growing Canadian Goose population, 40-50 Canadian Geese can be seen on lawns at one time, the DNR recommends a nest destruction program. Resident asks the Board for a resolution allowing such nest destruction.

B. Approval of Contract for Oakland County Equalization Services

Supervisor Gambka states we have previously entered into three (3) year contracts with Oakland County and they are now requesting a one (1) year contract with no changes. Trevethan states the change to a one (1) year contract serves to keep everyone on same schedule.

C. Resolution for Michigan Department of Natural Resources, Canadian Goose and Mute Swan Nest Destruction Program (or Goose and Mute Swan Round-up/Removal Program)

Supervisor Gambka states the Canadian Goose population on Tipsico has grown and continues to spread. If their nests and eggs are destroyed, they will leave the area. A 70% resident approval is necessary or a Board Resolution. Supervisor Gambka states he receives many resident complaints on this matter. lake residents should be asked individually, the Board should not speak for the residents. Supervisor Gambka suggests removing Mute Swans from the Resolution as a compromise. Supervisor Gambka states Goose Busters will catch and relocate the geese. Supervisor Gambka states most people do not wish to hurt the geese so destroying the nests will solve the problem. Miller asks if DNR has conducted an actual count in order to determine if there exists an over population. Miller contacted the DNR and was informed that 70% of home owners need to sign the petition, no lake property owners have contacted them regarding this problem and permits/training required. Miller also does not feel this is a Township Board of Trustees decision; it is a Tipsico Lake Board decision. Supervisor Gambka states he serves on the Tipsico Lake Board. Unidentified Resident states there are PETA and Humane Society approved methods of removal. Supervisor Gambka states a Resolution needs to be voted on and passed in order to get people trained in nest destruction before season begins, we will strike Mute Swans from Resolution. Supervisor Gambka states the Resolution could apply to all Rose Township Lakes and the eggs need to be removed/destroyed so the geese do not sit on them. Trevethan states the Board does not have enough information at this time by which to make an informed decision on this matter.
