1. Amendment to Chapter 10, Article II, Sec 10-37 Schedule of Fees and Charges, Cemeteries, Proposed Resolution 2026-XX
2. Amend Cemetery Fees, Proposed Resolution 2026-XX

4. Opposition to House Bills 5529-5532 and HB 5581-5585 Regarding Local Municipal Zoning Authority

Description: These bills focus on housing supply and zoning reform. They generally limit local government control (preemption) over zoning rules to standardize development statewide.

Main policy themes: smaller, more affordable housing, faster development approvals, fewer local restrictions on land use
