**A RESOLUTION TO AMEND THE ROSE TOWNSHIP ORDINANCE, Chapter 10, Article II, Sec 10-37
Schedule of Fees and Charges, Cemeteries**

WHEREAS, the Rose Township Board is authorized to manage and regulate Township cemeteries pursuant to applicable Michigan law; and

WHEREAS, the Township Board finds it necessary and appropriate to establish clear policies regarding cemetery fees and charges; and

WHEREAS, the Township desires to amend its Cemetery Ordinance to provide for the establishment, maintenance, and amendment of a schedule of fees and charges;

NOW, THEREFORE, BE IT RESOLVED, that the Rose Township Board hereby amends Chapter 10, Article II, Sec 10-37 Schedule of Fees and Charges, Cemeteries: Cemetery Fees and Charges

(a) The Township Board shall maintain a schedule of fees and charges applicable to Township cemeteries, including but not limited to fees for burial spaces, interment services, disinterment, foundations, and other cemetery-related services.

(b) The schedule of fees and charges shall be adopted by resolution of the Township Board and shall be kept on file in the office of the Township Clerk.

(c) The Township Board may amend the schedule of fees and charges from time to time by resolution.

(d) All cemetery fees and charges shall be paid in advance to Genesee Valley Vault unless otherwise authorized by the Township Board or its designee.

BE IT FURTHER RESOLVED, that all other provisions of the Cemetery Ordinance not inconsistent with this amendment shall remain in full force and effect.

BE IT FURTHER RESOLVED, that this amendment shall take effect upon adoption and publication as required by law.

Motion by Treasurer Jobes to amend Chapter 10, Article II, Sec 10-37 Schedule of Fees and Charges, Cemeteries, Proposed Resolution 2026-05. Supported by Trustee Maher. A roll call vote was taken. Bourdeau- yes; Miller – yes; Maher – yes; Stilwell – yes; Jobes – yes. The motion was carried 5/0.

Motion by Clerk Miller to approve the cemetery fees as presented, Proposed Resolution 2026-06. Supported by Trustee Maher. A roll call vote was taken. Stilwell – yes; Miller – yes; Jobs – yes; Bourdeau – yes; Maher – yes. The motion was carried 5/0.

3. Authorization to Transfer \$450,000 from the Fire Fund to the General Fund as Repayment of Prior Loan, Proposed Resolution 2026-07

This proposed transfer represents repayment/adjustment of a prior funding arrangement. The board clarified that the original transfer to the Fire Fund was not a loan (as incorrectly stated in the agenda item) but a prior budget adjustment. The funds remain township-controlled, and no grant funds were included in the original transfer into the Fire Fund. The goal is to better account for township finances and fund balances. The attorney confirmed that the transfer from the Fire Fund into the General Fund is allowed.

Public Comment: potential that the initial transfer may have contained grant funds (it was confirmed that no grant funds were transferred to the Fire Fund)

Resolution 2026-07

RESOLUTION AUTHORIZING REPAYMENT OF PRIOR FIRE FUND LOAN TO GENERAL FUND

WHEREAS, the Rose Township Board of Trustees is responsible for the fiscal management of Township funds; and

WHEREAS, the Township previously advanced \$450,000 from the General Fund to the Fire Fund to support operational needs, as documented in the June 8, 2022 Board Meeting; and

WHEREAS, under Michigan Compiled Laws 41.801, the Township Board is authorized to make transfers or loans between funds when necessary and appropriate; and

WHEREAS, the Township Board has reviewed the current financial condition of the Fire Fund and General Fund and determined that the Fire Fund is in a position to repay the prior advance; and

WHEREAS, the Township Board finds that repayment of the prior loan is in the best interest of proper accounting, fiscal responsibility, and maintaining transparency in Township financial operations;

NOW, THEREFORE, BE IT RESOLVED, that the Rose Township Board of Trustees hereby authorizes the transfer of **\$450,000 from the Fire Fund to the General Fund** as full repayment of the prior advance made from the General Fund; and

BE IT FURTHER RESOLVED, that the Township Supervisor and Clerk are authorized to make all necessary budget amendments and accounting entries to reflect this repayment; and

BE IT FURTHER RESOLVED, that this transfer and repayment is made in accordance with Michigan law and the Township Board's determination of fiscal necessity; and

BE IT FURTHER RESOLVED, that all resolutions or parts of resolutions in conflict herewith are repealed to the extent necessary to give this Resolution full force and effect.

Motion by Treasurer Jobes to transfer \$450,000 from the Fire Fund to the General Fund as repayment of a prior transfer and to authorize the Township Supervisor and Clerk to make all necessary budget amendments and accounting entries to implement this transfer, Proposed Resolution 2026-07. Supported by Trustee Maher. A roll call vote was taken. Maher – yes; Bourdeau – yes; Miller – no; Jobes – yes; Stilwell – yes. The motion was carried 4/1.

4. Resolution Opposing house Bills 5529-5532 and House Bills 5581-5585 Regarding Local Municipal Zoning Authority, 2026-09

Supervisor Stilwell expressed concern over loss of local zoning control and impact on rural character. If enacted, these bills would override local zoning and establish smaller lot sizes and home sizes. The board shared their concerns over the proposed bills.

RESOLUTION IN OPPOSITION TO THE PASSAGE OF MICHIGAN HOUSE OF REPRESENTATIVE BILLS 5529–5532 AND 5581–5585 REGARDING LOCAL MUNICIPAL ZONING AUTHORITY

Whereas, at a regular meeting of the Township Board of Trustees of Rose Township, held at the Rose Township Hall on the eighth day of April 2026, the following resolution was offered by Maher and supported by Bourdeau; and

WHEREAS House Bills 5529–5532 and 5581–5585 (hereinafter the “Bills”) have been introduced in the Michigan House of Representatives; and

WHEREAS, the Bills have been referred to committees of the Michigan House of Representatives for consideration; and

WHEREAS the Bills would, if enacted into law, impose new requirements for studies and documentation for site plan review that would circumvent established local planning processes; and

WHEREAS, the Bills would restrict minimum home square footage requirements, thereby placing additional pressure on local infrastructure, including water and sewer capacity; and

WHEREAS, the Bills would modify parking and mobile home requirements, disrupting decades of planning reflected in Rose Township’s current zoning and Master Plan developed with community input; and

WHEREAS the Bills would restrict the Township’s authority to regulate spacing between residential homes; and

WHEREAS the Bills would permit duplexes on parcels currently zoned for single-family residential use; and

WHEREAS Michigan law has traditionally delegated zoning authority to local municipalities, including townships; and

WHEREAS local communities are best positioned to determine appropriate land use, plan orderly development, and adopt zoning regulations; and

WHEREAS local communities are best able to evaluate infrastructure capacity to ensure responsible growth; and

Whereas local communities must retain the ability to balance development with the health, safety, and welfare of current and future residents.

NOW, THEREFORE, BE IT RESOLVED, that the Township Board of Trustees of Rose Township hereby opposes the passage of Michigan House Bills 5529–5532 and 5581–5585 on the grounds that local municipalities are best suited to regulate zoning in the interest of their residents; and

BE FURTHER RESOLVED that copies of this Resolution shall be transmitted to all state legislators representing residents of Rose Township; and

BE IT FURTHER RESOLVED that all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent necessary to give this Resolution full force and effect; and

BE IT FURTHER RESOLVED that this Resolution is severable and if any provision is found invalid, the remaining provisions shall continue in full force and effect.

Motion by Trustee Maher to oppose House Bills 5529-5532 and House Bills 5581-5585 regarding Local Municipal Zoning Authority, Proposed Resolution 2026-09. Supported by Trustee Bourdeau. A roll call vote was taken. Stilwell – yes; Miller – yes; Maher – yes; Jobses – yes; Bourdeau – yes. The motion was carried 5/0.

5. Update to Master Plan for the Sub-Area at Hickory Road and Rose Center Roads

Treasurer Jobs stated that the Planning Commission reviewed 5-acre vs. 10-acre parcel options and recommended moving forward with primarily 10-acre parcels. A supporting board vote tonight will initiate the 42-day public comment and review period. The draft Master Plan will also be sent to appropriate surrounding agencies for their review and comment.

Clerk Miller read highlights from the Planning Commission meeting regarding their discussion of the draft plan and subsequent action to forward it to the Township Board.

Supervisor Stilwell stated that the draft plan received tonight could change before approval based on public comment during the 42-day period and a public hearing which will be held after the comment period has closed.

Public Comment: a resident requested clarification regarding the public comment period.

Motion by Treasurer Jobs authorize the distribution of the draft Master Plan for the public review period. Supported by Trustee Maher. A roll call vote was taken. Stilwell – yes; Maher – yes; Jobs – yes; Miller – yes; Bourdeau – yes. The motion was carried 5/0.

The draft plan will be available at the office and online for public review and comment.

PUBLIC COMMENT

Springfield Township resident gave an update on opposition efforts to the proposed mining operation in Springfield Township and invited participation in an upcoming event, purchase of signs, and option to sign a petition expressing opposition.

Resident raised concerns regarding data centers, AI-related infrastructure, and need for township communication and policy clarity.
